## Participant Agreement and Release

I understand that the delivery and installation of the garden and gardening materials will tentatively take place on Saturday, May 18, 2013. I grant permission for entry to my property by BBC and its agents, volunteers, and contributors. I agree to release, indemnify, and hold harmless BBC and its officers, members, volunteers and contributors from any and all liability in connection with any loss, damage, or injury as may be related to the event day and the entire course of the Backyard Garden Program.

I agree that I or a member of my family will be present during the delivery and installation of garden and gardening materials, including eight GardenSoxx filled with organic compost, vegetable plant seedlings, care guide, and recipe book. I further understand that all able bodied individuals living in my home or visiting are required to assist with unloading garden materials, installing the garden, and planting vegetable plants on event day. I will also allow volunteers to use my bathroom or provide water on event day, if requested. BBC will notify me of any changes to the schedule.

I agree to care for my backyard garden to the best of my ability, including watering it twice daily, weeding it when necessary, picking vegetables when they are ready to be picked, and otherwise keeping it healthy and presentable. I agree to review the care guide in its entirety and attend a garden maintenance workshop on one of two dates listed in the application. I understand that my failure to adequately care for my garden may render me ineligible for other programs and services offered by BBC and its partners.

I understand that I will not be charged for the garden and gardening materials and the installation labor performed. I also understand that none of the garden or gardening materials are warranted or guaranteed. I acknowledge that I may use the GardenSoxx for three growing seasons.

I acknowledge that BBC is available to provide reasonable technical advice to owner on the maintenance of the backyard garden at the owner's request. In fulfillment of this commitment, BBC may rely on the technical expertise of its partners.

I hereby assign the rights to any video, photographic recording(s), or photos made of me, my home, or family during event day to BBC. I hereby authorize the editing, duplication, reproduction, copyright, exhibition, broadcast and/or non-profit use and distribution of said recording(s) for purposes deemed suitable by BBC.
